The registration will commence at **04:00 PM** on the start date.

Note: -

1) Candidates who **failed or were absent** for the **RP examination on 2<sup>nd</sup> Saturday** can re-apply for the **same course** scheduled on **4<sup>th</sup> Saturday**. Registration for such candidates will **open tentatively 4 working days after the 2<sup>nd</sup> Saturday exam date**. Seats will be allotted on a **first-come, first-served basis**.

**Example:**

Candidates who **failed or were absent** for the **Certified Information System Banker** exam held on **11.04.2026 (2<sup>nd</sup> Saturday)** can register again for the **same course** from **16.04.2026 at 04:00 PM**.

2) The RP examination will be conducted in 3 sessions a day. The session timings are 10.00 am to 12.00 pm, 12.45 pm to 2.45 pm, and 3.30 pm to 5.30 pm. Candidates can select the time of his/her choice.

3) Registration will be on first come first served basis. We urge candidates to register as early as possible to avoid disappointment.

4) The candidates who wish to register for e-learning may do so by paying e-learning fees.
